

ORDINANCE NO. 2009-11-067

AN ORDINANCE RELATING TO THE 2009 BUDGET APPROPRIATING \$1,315,000.00 OF ADDITIONAL REVENUE AND EXPENSES FOR THE DESIGN AND CONSTRUCTION OF THE OHIO / KING / I-5 RAMP PROJECT. THE FUNDING CONSISTS OF A FEDERAL HIGHWAY INDIRECT GRANT OF \$315,000 AND A \$1,000,000.00 INTERLOCAL SERVICE REVENUE AGREEMENT BETWEEN THE CITY OF BELLINGHAM AND THE STATE OF WASHINGTON, DEPARTMENT OF TRANSPORTATION

WHEREAS, the City of Bellingham is planning a project that will provide improvements at the intersection of King / Ohio / I-5 ramps by adding curbing, turn lanes, truck shoulders, and a new signal, hereinafter the "Project," and;

WHEREAS, the City of Bellingham has received a \$315,000.00 Federal Highway Administration pass through Grant from the Washington State Department of Transportation, and;

WHEREAS, the Project will complete one of the 2005 Legislature identified downtown off-ramp reconstruction, and;

WHEREAS, the 2005 Legislature appropriated to the STATE One Million Dollars, (\$1,000,000) of Transportation Partnership Account funds to be applied toward the Project, and;

WHEREAS, the Parties deem it is in the best interest of the public for the City of Bellingham to perform or cause to be performed all design, right-of-way acquisition, and construction work for this Project, and;

WHEREAS, the City has been notified that it will receive up to \$1,000,000.00 in reimbursement funding from the State of Washington, Department of Transportation.

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

Section 1. The sum of \$315,000.00 is hereby appropriated in the Street Fund. The source of funding will be credited from:




