

ORDINANCE NO. 2010-07-044

**AN ORDINANCE RELATING TO THE 2010 BUDGET APPROPRIATING \$119,066.00 FROM ESTIMATED ENDING UNDESIGNATED RESERVES IN THE STREET FUND TO BE USED FOR PAYMENT TO WHATCOM COUNTY ASSOCIATED WITH THE BAKERVIEW / JAMES ANNEXATION.**

**WHEREAS**, on December 19, 1997, the City of Bellingham and Whatcom County entered into an Interlocal Agreement concerning annexations; and,

**WHEREAS**, the agreement states that the City will reimburse the County for the depreciated value of major capital construction expenditures the County has made in the annexation area during the ten years prior to the effective date of the annexation; and,

**WHEREAS**, on September 11, 2006, the Bellingham City Council approved Resolution 2006-41 thereby initiating the East Bakerview/James Street annexation; and,

**WHEREAS**, on December 8, 2008, the Bellingham City Council approved Resolution 2006-41 East Bakerview/James Street annexation with an effective date of March 6, 2009., and,

**WHEREAS**, the projects within this annexation that meet this criteria are the James Street / Telegraph intersection and the James / Bakerview signalization projects.

**NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:**

The sum of \$119,066.00 is hereby appropriated in the Street Fund. The source of funds will be credited from:
