

### Short History

The Arboretum was established in 1974 through an “Inter-Local Cooperation Agreement” between the City of Bellingham and Western Washington State College. There have been several iterations of the agreement over the years, with the most recent version signed in 2016, and due to expire in 2025. This shared stewardship model is grounded in the core intent that the Arboretum is to be preserved in a natural state to the greatest extent possible, devoted to educational, aesthetic, low impact recreation, and research activities. Past and future development determined to be consistent with those activities is required to be compatible with sound ecological principles.

## 2019 Activities Report

### Board Members & Officers

2019 saw some stabilization to the board membership with a full roster for nearly the entire year and the continued service of several members. The Board did lose the longest serving member of the Board, Mike Reed, as he decided to move on to other interests. His interest and passion in the Arboretum will be missed! Below is a summary of board members who served and whose terms expired during this report period:

### Web Site Improvements & Modernization

The Board reviewed the content of an unmanaged Arboretum web site that had been created by WWU students at some time in the past. With the gracious help of the City Parks and Recreation web manager, an official Arboretum web site was created under the broader City Parks web site, and will be officially managed through the Parks Department from now on.

### Student & Volunteer Work

The Parks and Recreation Department increased its presence in the Arboretum with the hiring of an additional volunteer coordinator. This new position helped create several professionally guided opportunities for citizens and WWU students to contribute to the maintenance and health of the Arboretum.

Mary Childress, our student appointee, completed a directed study of fungi in the Arboretum under the supervision of Professor Tuxill. Her presentation was included in the November 2019 minutes.

### Stewardship.

- In response to a localized landslide, the WWU grounds crew removed the outdoor learning center seating off the Huntoon trail.
- The grounds crew also made repairs to several washed out locations on the Huntoon trail and the Jersey Street trail.
- Under the City's Memorandum of Agreement, the Washington Trails Association made repairs and improvements to the Elderberry Trail.

## **Sponsorship**

The Board voted to include the Arboretum in the City's bench donation program, identifying several suitable locations for benches. The first donated bench was installed along the Huntoon trail.

## **Goals of the Board**

1. Eradicate invasive species. Numerous student groups and interested citizens sporadically approach the Board with proposals to remove invasive species in certain locations. The Board welcomes and encourages these proposals!
2. Continue working with the Washington Trails Association to improve and maintain trails within the Arboretum.
3. Raise the profile of the Arboretum through public service announcements and articles.
4. Encourage collaborative partnerships with community organizations interested in preserving and maintaining the Arboretum.
5. Establish a stewardship program for trail maintenance, user awareness, and other issues.
6. Review, and if necessary, amend by-laws and policies.
